LOAN OF A MARE FORM

HRNSW has developed an opportunity for Breeders to access Broodmares, whilst not being the Broodmare Owner.

A "LOAN OF A MARE FOR BREEDING A FOAL" form has been designed to alleviate the issue associated with 'leasing' mares for breeding purposes given the definition of 'Breeder' is listed as the Owner of the Broodmare as at the last service date.

The associated issue is when a Broodmare owner repossesses the ownership of a leased Broodmare.

For Example:

A leased Broodmare has a foal for the Lessee and is then re-served by the Owner prior to the lease lapsing.

As the resultant foal was conceived prior to the lease lapsing, the records are showing the Lessee as the Breeder instead of the Owner who had repossessed and served the Broodmare.

The form eliminates the example listed above and also the need for Owners to lease Broodmares and **MUST** be lodged with the Certificate of Service/Foal Notification form to ensure the correct Breeder is recorded.

There will be a minimal administration fee of \$10 (GST Exempt) for the processing of the registered breeder.
